CCARDESA THIRD GENERAL ASSEMBLY 2023

Durban, South Africa 5-8 June, 2023

1. Background

The Centre for Coordination of Agricultural Research & Development for Southern Africa (CCARDESA) was established in 2010 by SADC Member States as a subsidiary organisation of SADC with a mandate of coordinating agricultural research in Southern Africa. CCARDESA supports a range of initiatives that promote technology generation, dissemination and adoption. This is in line with the Regional Indicative Strategic Development Plan (RISDP) of SADC, the Regional Agricultural Policy (RAP), CAADP and Malabo Declaration. The ultimate goal of CCARDESA is to contribute to improved regional food security and livelihoods. As a sub-regional research organisation, CCARDESA fosters inter-country collaboration in the region and links Southern Africa to other regional, continental & global organisations.

CCARDESA pursues a vision of sustainable agricultural growth and socio-economic development in the SADC region. This vision is supported by the institutional mission of setting the regional research and development agenda, mobilising resources, supporting capacity development, fostering collaboration and providing agricultural information and knowledge. The mission and vision are contained in the CCARDESA Strategy 2020-2029 as well as the Medium-Term Operational Plan (MTOP) 2021-2025. The Strategy and Operational Plan are successors to the first Operational Plan (2014-2018) that also served as a Strategy document for CCARDESA.

The CCARDESA MTOP describes thematic areas, compound activities over the next 5 years and the expected outputs. All these have been designed to support the achievements of the following overall objectives of CCARDESA contained in the Charter:

- 1. To promote coordination and collaboration among the National Agriculture Research Systems (NARS) and Farmer Organisations through regional and international cooperation;
- 2. To facilitate the exchange of information and technology among the agricultural research and development (R&D) institutions;
- 3. To promote partnerships in the SADC region between public, private, civil society and international organizations in agricultural R&D;
- 4. To improve agricultural technology generation, dissemination and adoption in the region through collective efforts, training and capacity building; and
- 5. To mobilise human, financial and technological resources to implement demand-driven regional R&D activities that will contribute to the strengthening of national-level institutions/research agencies and individuals.

2. Governance structure and the General Assembly

The institutional arrangement of CCARDESA is summarised in Annex 1. The Ministers responsible for Agriculture and Food Security of countries that are party to the CCARDESA Charter constitute the highest policy body. Ministers have powers of appointment and approval of specific issues. Below the Ministers is the General Assembly of regional stakeholders from SADC Member States, with its own defined powers in the governance of CCARDESA. The Board of Directors of CCARDESA, composed of 13 members, provides oversight and guides the CCARDESA Secretariat on its general direction and programmes. The Board reports to the General Assembly. The CCARDESA Secretariat is answerable to the Board of Directors of CCARDESA, through its Executive Director. The Secretariat performs the day-to-day

functions of CCARDESA by managing and implementing the programmes of the organisation, as approved by the Board, and performing all tasks of coordination of agricultural research and development in the SADC region.

The General Assembly (GA), composed of all stakeholders, is an importance structure within the governance of CCARDESA. The GA is responsible for providing broad guidance to the Board and ultimately to the CCARDESA Secretariat. The key responsibilities of the General Assembly are:

- 1. Recommend to Ministers CCARDESA's R&D priorities;
- 2. Approve, Monitor and Evaluate the CCARDESA strategic direction;
- 3. Appoint, renew or terminate the services of External Auditors for CCARDESA; and
- 4. Recommend to Ministers new members on CCARDESA Board identified by the sitting Board.

The Governance Manual of CCARDESA states that the General Assembly shall be held every two years. The first GA of CCARDESA was held in May 2014 in Gaborone. At the first GA meeting, the MTOP for CCARDESA was approved, the composition of the Board was endorsed and the Auditors were approved. The second GA which was supposed to be held in 2016 did not take place due to challenges the organisation was facing at that time. Following the stabilisation of the organisation, the second GA was held virtually on 12th June 2021. As per procedure, the 3rd CCARDESA GA will be held on 5th June, 2023 in Durban, South Africa on the side lines of the FARA Africa Agricultural Science Week (5-8 June, 2023) which will be co-hosted with CCARDESA.

The Africa Agricultural Science Week (AASW) is an event relevant for all players in the agricultural value chain and is poised to become the leading science-to-business platform on the African Continent. Accordingly, the event will have significant economic and legacy impacts on the agribusiness ecosystem in the region. CCARDESA will participate in the AASW and strategically hold relevant side events as well as leverage on the attendance of the AASW to convene its third GA. CCARDESA is implementing strategic programmes such the Agricultural Productivity Programme for southern Africa (APPSA), the Comprehensive Africa Agriculture Development Programme ex-pillar 4 (CAADP-XP4), Global Climate Change Alliance plus (GCCA+), Climate Resilience and Natural Resources Management (C-NRM) and the Food Systems Resilience Programme (FSRP). The GA will give CCARDESA an opportunity to showcase its work under different programmes and hold its governance meetings at the side-lines of this continental spectacle.

Following 3 years of implementing the above-mentioned strategies, the CCARDESA Board has directed the CCARDESA Secretariat to review its long-term strategy and align it to the organisational organogram. The 3rd GA will provide an opportunity for stakeholders to endorse the revised strategies.

3. Objectives

The objective of the forthcoming GA is to provide a platform for the governance structure of CCARDESA to perform its mandate as provided for in the charter.

4. Participation

All regional stakeholders in the agricultural sector are eligible to attend the CCARDESA General Assembly. Therefore, the General Assembly is highly inclusive, and it is designed to

bring together diverse institutions and individuals involved in the agricultural sector. These include organisations in the Public Sector, Agro-Industry, Agricultural Education Institutions, Farmer Organisations, Agricultural Non-governmental Organisations, faith-based organisations involved in agriculture and agricultural marketing organisations.

5. General Assembly Programme and expected outputs

It is the intention of CCARDESA to always combine the business of the CCARDESA General Assembly with technical sessions related to CCARDESA programmes. During the first General Assembly, the programme lasted two days. There were exhibitions and side events alongside the main business meeting of the General Assembly. Unlike the GA of 2021, which was conducted virtually due to Covid-19 related travel restrictions, the 3rd GA will be a face-to- face meeting combining with the AASW and possibly a CCARDESA Board meeting with side events. The detailed draft GA programme is presented in Annex 2.

At the end of the General Assembly, the following outputs are envisaged:

- 1. CCARDESA Strategic Plan endorsed;
- 2. Board of Directors of CCARDESA endorsed;
- 3. CCARDESA Medium Term Operational Plan endorsed; and
- 4. Chairperson of the General Assembly elected.

6. Registration and further information


